1.02 WORK BY AUTHORITY

- A. PennDOT Occupancy and Railroad permits are to be prepared by the contractor/developer under the Authority's name. The Authority will review and sign-off the permit.

1.03 AUTHORITY FURNISHED PRODUCTS

1.04 CONTRACTOR USE OF SITE AND PREMISES

- A. Limit use of site and premises to allow:
 - 1. Authority occupancy.
 - 2. Use of site and premises by public.
- B. Construction Operations: Limited to areas noted on Drawings.
- C. Time Restrictions for Performing Work: None.
- D. Utility Outages and Shutdown: None.

1.06 WORK IN STATE HIGHWAYS

A. State Highway Inspection Fees

- 1. The Contractor shall include in his pricing, the cost for all State Highway inspection fees. These fees shall be paid to the Pennsylvania Department of Transportation (PennDOT) by the Authority and deducted from any amount due the Contractor, or shall be paid to the Authority by the Owner at the time the pre-construction conference is held.

B. PennDOT Specifications

- 1. The Contractor is advised that strict adherence to PennDOT Specifications, Publication 408, dated 1990 and Chapter 459, Occupancy of Highways by Utilities of the Pennsylvania Code, Title 67, dated July 1989 is mandatory on all Work being done in the State Highways.

- a. Latest revision to both publications shall apply.

- C. For all work in Pennsylvania Department of Transportation Rights-of-Way, a Highway Occupancy Permit will be prepared by Owner's Engineer in the Authority's name. Owner will pay all appropriate fees.

1.07 WORK IN RAILROAD RIGHTS-OF-WAY

- A. For working in Railroad Rights-of-Way, permits will be prepared by Owner's Engineer in the Authority's name. Owner will pay all appropriate fees.

1.08 WORK SEQUENCE

- A. Construct Work to accommodate Authority's requirements during the construction period, coordinate construction schedule and operations with Engineer.

1.09 AUTHORITY OCCUPANCY

- A. The Authority will occupy the site during entire period of construction for the conduct of normal operations.
- B. Cooperate with Contractor to minimize conflict, and to facilitate Authority's operations.
- C. Schedule of Work to accommodate this requirement.

1.10 UNIT COSTS

- A. When bidding, the Contractor shall take into consideration the additional costs which may be incurred when working in PennDOT or Railroad Rights-of-Way.
- B. No additional compensation will be allowed by the Authority.

1.11 SAFETY

- A. The safety provisions or applicable laws, regulations of the Pennsylvania Department of Labor and Industry, and building and construction codes shall be observed. Machinery, equipment and other hazards shall be guarded in accordance with the safety provisions of the "Manual of Accident Prevention in Construction", published by the Associated General Contractors of America, to the extent that such provisions are not in contradiction of application of state and local laws.

Observance of, and compliance with, said regulations shall be solely and without qualification, the responsibility of the Contractor without any responsibility whatsoever on the part of the Authority or Authority's Engineer. The duty of enforcing such laws and regulations lies with the said Department not with the Authority or Authority's Engineer.

- B. The provisions of the "OCCUPATIONAL SAFETY AND HEALTH ACT OF 1970" of the U.S. Department of Labor shall be complied with in the performance of all work. Observance of, and compliance with, said Act shall be solely and without qualification the responsibility of the Contractor without reliance on superintendence of, or direction by, the Authority or Authority's Engineer. The duty of enforcement of the provisions of the Act lies with the U.S. Department of Labor not with the Authority or Authority's Engineer.
