## 1.04 SIGNS, SIGNALS, AND DEVICES

- A. Post Mounted Traffic Control: Specified in PennDOT Publication 203.
- B. Flagmen Equipment/Apparel, traffic cones, drums, flares, and lights shall be PennDOT approved when working on State highways.
- C. Traffic control schemes as shown in Publication 203 shall be used on State highways for respective operations.
- D. Local jurisdictions may apply in other areas of application.

# 1.05 CONSTRUCTION PARKING CONTROL

A. Control vehicular parking to prevent interference with public traffic and parking, access by emergency

- vehicles, and Authority's operations.
- Monitor parking of construction personnel's vehicles. Maintain vehicular access to and through parking areas.
- C. Prevent parking on or adjacent to access roads or in non-designated areas.

# 1.06 CONSTRUCTION SITE WORK/DELAYS

- A. Provide trained and equipped flagmen to regulate traffic when construction operations or traffic encroach on public traffic lanes.
- B. When extended delays to traffic movement are anticipated while working in highways and streets, the Contractor shall notify all School Bus operations at least 48 hours in advance.
- C. Public shall also be notified in advance by newspaper and radio announcements.
- D. Any detours shall be approved by respective jurisdiction.

## 1.07 FLARES AND LIGHTS

A. Use flares and lights during hours of low visibility to delineate traffic lanes and to guide traffic.

## 1.08 HAUL ROUTES

- A. Consult with Authority having jurisdiction in establishing public thoroughfares to be used for haul routes and site access.
- B. Confine construction traffic to designated haul routes.
- C. Provide traffic control at critical areas of haul routes to regulate traffic, to minimize interference with public traffic.

# 1.09 TRAFFIC SIGNS AND SIGNALS

- A. At approaches to site and on site, install at crossroads, detours, parking areas, and elsewhere as needed to direct construction and affected public traffic.
- B. Relocate as work progresses to maintain effective traffic control.

### 1.10 REMOVAL

- A. Remove equipment and devices when no longer required.
- B. Repair damage caused by installation.
- C. Remove post settings.
